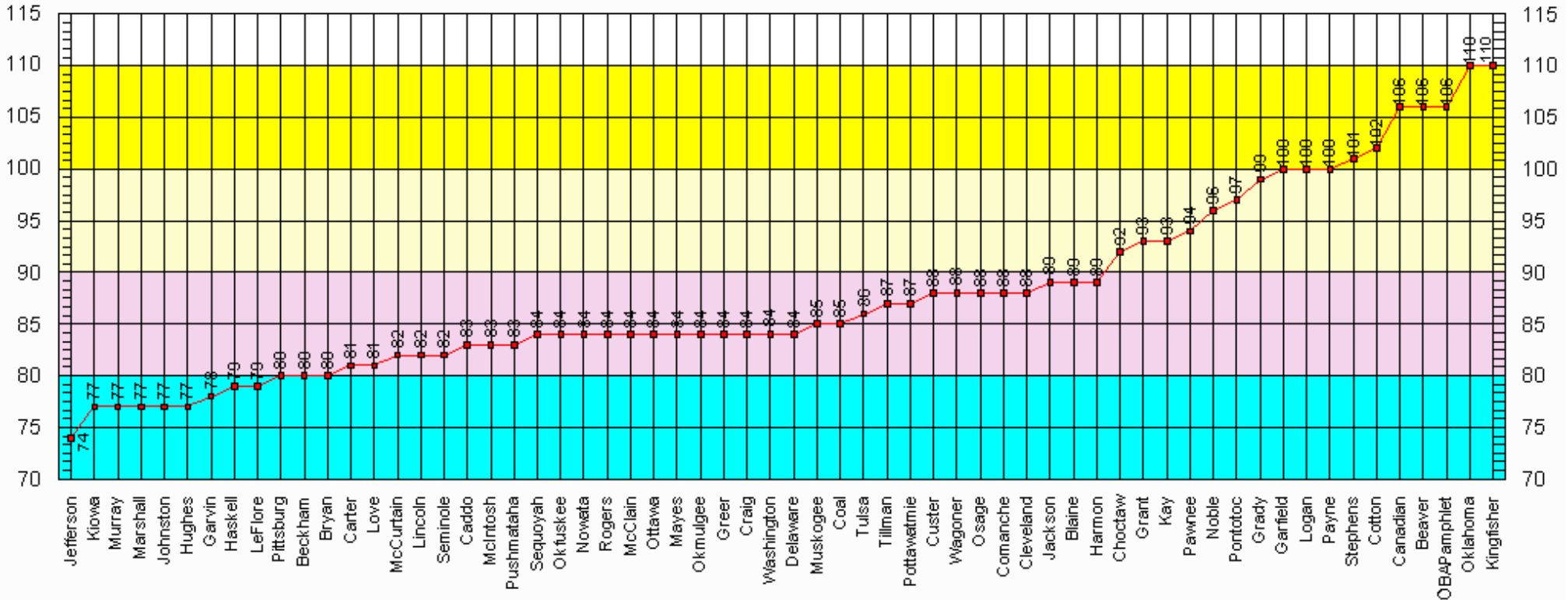


SUMMARY OF OKLAHOMA "STANDARD" VISITATION SCHEDULES AS OF AUGUST 2003 ¹

The chart, below, shows the estimated "visitation nights" (left and right columns) for each county having an official or defacto standard visitation schedule. The chart excludes those counties for which court personnel flatly stated to my assistant or me that NO schedule of minimum (or other) schedule of visitation exists in such counties, to wit: **ADAIR, ALFALFA, ATOKA, CHEROKEE, CIMARRON, CREEK, DEWEY, ELLIS, HARPER, LATIMER, MAJOR, ROGER MILLS, TEXAS, WASHITA, WOODS & WOODWARD** counties. Other counties which have no minimum (or other) schedule of visitation, but which nonetheless appear to have a "typical" defacto standard visitation order or at least a judge-specific standard order ARE included in this report, to wit: **BECKHAM, COMANCHE, CRAIG, DELAWARE, GARFIELD, MAYES, NOWATA, OKMULGEE, OTTAWA, ROGERS, TILLMAN, TULSA, and WASHINGTON.**

¹ This report states and compares county-by-county provisions for "regular", "holiday", "special", and "summer" visitation. Unless otherwise noted, the holidays identified alternate between parents. Christmas is handled differently in this table. Typically, Christmas/New Year's Break includes 14 calendar days. Several counties alternate Christmas like this: a) day school is out through December 24 p.m.; b) December 25 through December 30, 31 or January 1. Hence, the split is not 50/50 over two years or more since school can recess as late as December 22 or 23 and school often does not resume on January 2. The "Approx Annual Total Nights" column is the approximate visitation overnights on a 2 year average, and should be correct within a margin of error of 3-4 nights per year. No attempt has been made to "fine tune" the approximate annual totals – these numbers should NOT be used for litigation purposes in which more exacting precision would be important for child support computation. Here, the purpose is to render a roughly accurate approximate number of annual nights for county-by-county comparison purposes. The phrase, "Day only" means part of a day – hours vary. Sources for included schedules are indicated for each county.
